#### 43. MATTERS ARISING

# a) Communities Together Fund (TAP Fund)

For 2018/19, the previous Town and Parish (TAP) fund has been relaunched across the Country as the Communities Together Fund. The aim of the Communities Together Fund is to encourage communities to work together; identifying new ideas for their mutual benefit. Applications are welcome from community projects benefiting, enhancing and making a difference to communities.

A list of the types of community project applications which would be welcomed are:-

- Reducing social exclusion/increasing social inclusion,
- Improving community capacity, cohesion and connectedness,
- · Reducing loneliness and/or isolation across and between all ages,
- Improving community safety, promoting good citizenship and kindness/reducing anti-social and criminal behaviour,
- Encouraging life-long learning and development/improving productivity and prosperity,
- Encouraging and increasing volunteering and employment prospects and opportunities,
- · Improving physical, mental and emotional health and well-being,
- Improving living conditions/tackling homelessness,

**Resolved:** Ideas were discussed but Members needed time to consider projects. The Clerk will circulate types of eligible projects.

#### b) Entrance to Hares Close

It has been brought to Chagford Parish Councils attention that when traffic is going in and out of Hares Close they are not aware that there is still a pavement running along this road. Pedestrians are also not aware of cars going in and out of Hares Close, especially children who use this route to get to School. The Clerk has written to Blue Cedar requesting that temporary signs be put up at the entrance to Hares Close warning both vehicles and pedestrians. Blue Cedar informed the Council that the road

is configured as per the requirements of the Highway Authority and it would not be Blue Cedar's responsibility to erect signs without consulting the Highway Authority. **Resolved:** to invite a representative from Blue Cedar to meet with the Parish Council to discuss this matter and others.

# 44. URGENT BUSINESS BROUGHT FORWARD AT THE CHAIRMAN'S DISCRETION

# a) Cross Tree Path (Min: 22(b) refers)

The Vice-Chairman reported that the Parish Council have not heard back from the PCC regarding the work at Cross Tree but felt that time was going on and, the Council needs to move forward with the repairs. The Clerk reported that she had heard back from the PCC and they were struggling to contact the Contractor to discuss the proposed work and other associated work that is needed. **Resolved:** Cllr: Williams will ask the contractor to contact the Clerk. The Clerk will also speak to the Church Office to ascertain the best time for the work to be carried out.

#### 46. FINANCIAL MATTERS

## a) Financial Group Report - Cllr: Mrs. Haxton

The accounts to date were considered to be within the projected parameters. The Lengthsman was paid for work carried out in February and March and will be claimed from the TAP fund in the autumn. The Council will need to decide whether to contract out again.

The receipts and payments book was checked against the invoices and statements.

The Financial Group considered requests for grants from Chagford Conservation Group, North Dartmoor Search and Rescue and Chagford Recreational Trust. It was suggested that the Council should give a grant of £220.00 to both the Chagford Conservation Group and North Dartmoor Search and Rescue.

The Recreational Trust need to upgrade the drive in order to comply with regulations now that it has the DAAT Landing Site and, to attract more trade. There is also a need for weighted gates to stop ponies coming in off Parley Hill and to stop them coming onto the cricket field. It was suggested to give an initial grant of £500.00. **Resolved:** to give Chagford Conservation Group and North Dartmoor Search and Rescue a grant of £220.00 each. Members would like in principle to give a £500 grant to the Recreational Trust but would like to see the proposed plans for the upgrade to the drive and the materials that will be used before providing the grant.

The Jubilee Field will require a lot of work in the autumn, trimming back hedges and general tidying up of the field. The play equipment is now twenty years old and is beginning to show signs of age. Should the Council be ring fencing some funds to replace some of the equipment?

The Council would like to support the WW1 centenary and suggest putting £500 aside to ensure that the entire Parish can join in.

The Burial Ground is still very necessary and the Chairman is having a meeting with the DALC secretary in order that we are working on up to date information. **Noted.** 

- **b)** Approval to pay Chagford Combined Charity for the hire of Endecott House. **Resolved:** to approve payment.
- **c)** Approval to pay Yewtopia for grass cutting of the Jubilee Field on 15/5 and 29/5 and the cutting of banks and verges. **Resolved:** to approve payment.
- **d)** Approval to pay Yewtopia for grass cutting of the Jubilee Field on 12/6 and 26/6, cutting banks and verges on 19/6 and spraying of weeds within the 30mph zone on 26/6. **Resolved:** to approve payment.
- **e)** Approval to pay WDBC for the Dog Warden Joint Partnership Scheme for the period01/04/2018 31/03/2019. **Resolved:** to approve payment.
- **f)** Approval to pay NDSR a grant of £220.00. **Resolved:** to approve payment.
