# 159 URGENT BUSINESS BROUGHT FORWARD AT THE CHAIRMAN'S DISCRETION

a) A letter had been received from Devon County Council regarding Drainage Maintenance Responsibilities. Following the Parish and Town Conference a great deal of interest was shown identifying who is responsible for maintaining and clearing drainage systems on and around the highway. In the majority of cases, the responsibility for ditch maintenance rests with the adjacent landowner, even if the ditches take water from the highway.

A factsheet titled Roads and farmers is produced by DCC and is available at www.devon.gov.uk/roadsandtransport/factsheet/road-and-farmers/

Equally, Landowners and occupiers are required, by law, to trim any hedge next to the public highway where growth is preventing the passage, or affecting the safety, of the highway user. **Noted.** 

b) The Okehampton Household Waste Recycling Centre will be undergoing significant maintenance works from 24<sup>th</sup> February 2020 until 22<sup>nd</sup> March 2020. During the works, the site will be closed to the public from 24<sup>th</sup> February until 1<sup>st</sup> March 2020 inclusive and 16<sup>th</sup> March until 22<sup>nd</sup> March 2020 inclusive. **Resolved:** to advertise on the Chagford Hub and Parish Notice Board.

c) The Okehampton Town Council has agreed to widen the remit of the Climate Change Working Group to include other parishes. Okehampton Town Council will be having a meeting on Tuesday 18<sup>th</sup> February from 3pm until 4.30pm in the Committee room to look at the results of the public consultation and to look at what we as a combined community can do. Noted.

Chagford Parish Council had concerns regarding parking and the Community Space should be classed as a Community Space (a noncommercial site).

#### Reports

# e) Climate and Ecology Working Group - Cllr: Ms Somme

The Climate and Ecology Working Group met on Monday 3<sup>rd</sup> February 2020. Approximately 15 parishioners attended.

The working group was divided up into three sub-groups

- Mapping Group to map the parish to show where we can improve habitat, where trees can be planted, it was suggested that a Community Tree Planting group should be set up. If one tree was planted by everyone on the electoral role 1200 trees would be planted.
- Tree and Nursery Group to find a suitable plot to have a tree nursery for growing saplings. Involving the children of the parish.
- Public Consultation Group
   To reach out to the wider community by going door to door with
   questionnaires, to involve the young people by contacting the
   school, invite a speaker to the Parish Assembly.
- The next meeting of the working group will be on 6<sup>th</sup> April 2020 at 7.30 p.m. in Endecott House. Noted.

# f) Tour of Waitrose, Okehampton – Cllr: Mrs. Haxton

Cllr: Mrs. Haxton had a guided tour of Waitrose to see how they dispose of their waste food and plastics. Waitrose and Partners is the largest employee-owned retailer. Reducing food waste and reducing plastic is a top priority and Waitrose have over 100 steps to be environmentally friendly and reduce the carbon footprint. Two double decker lorries deliver daily and Waitrose want to change the lorries to electric run vehicles.

Cardboard and plastic are compressed and collected by Leehans. A partnership with a charity called FareShare who is dedicated to fighting hunger. All surplus food waste is donated to the charity.

The aim of Waitrose is to eliminate unnecessary plastic and make all ownbrand packaging reusable or made out of recyclable or home-compostable material by 2023.

Plastic carrier bags have been removed from the stores. Waitrose has replaced loose fruit and vegetable plastic bags with an alternative, that can be composted and have removed plastic wrapping from multi pack items.

A pilot scheme was started in 2019 to test how customers might be prepared to shop differently, with the aim of saving plastic. The stores have a dedicated refillable zone, including dispensers for dry goods, coffee, beer and wine refills. **Noted.**

- c) Schedule One and Memorandum of Agreement from Touchwood for the new play equipment.

A document regarding the Terms and Conditions of the installation of the new play equipment has been received. This needs to be signed before the work can start. **Resolved:** as Cllr: Mrs. Malseed had been dealing with Touchwood the Parish Council will seek her views on the agreement before signing.

#### 163. CLERKS/CHAIRMANS REPORT

The Chairman welcomed Cllr: James McInnes from Devon County Council to give an update of the work going on at DCC.

£25,000 has been set aside to support Devon with Climate Change and they aim to be carbon neutral by 2030.

An increase of 5.5% has been put into Highways and officers are visiting parishes to ascertain the main problems and the main routes with issues will be mapped and priority given. Cllr: McInnes urged residents to report any potholes etc on the Devon County Council Web Site <a href="https://www.devon.gov.uk">www.devon.gov.uk</a>

Devon County Council are preparing their budget for 2020/21 the present budget will rise from 498 Million to 541 million.

A rise of 10% in Adult Services, 8.5% in Children's Services and 5.5% in Highways. **Noted.**
