## 65. CONFIRMATION OF MINUTES

a) The Minutes of the Regular Monthly Meeting held on Monday 12<sup>th</sup> September 2022 were confirmed and signed as a true record.

## 66. MATTERS ARISING

a) The Queen's Green Canopy Plaques and Trees (Min: 55(a) refers) Cllr: Rachel Short reported that two of the Aspen Trees have died. The Parish Council are still looking for a carpenter to mount the plaques. Resolved: Paul Bartlett, Stone Lane Gardens, will obtain replacement trees and the Parish Council will continue to look for a carpenter to mount the plaques.

## b) Noticeboard Outside the Birdcage (Min: 55(b) refers)

The noticeboard outside the Birdcage needs replacing. It was proposed that the noticeboard be of the same size and in aluminium or manmade timber. **Resolved:** quotes will be obtained for the noticeboard.

## c) Bike Stands (Min: 33(a) refers)

The Chairman has met with All Seasons and discussed the location and paving for the bike stands. Kirsty Howie has also spoken to All Seasons regarding which bike stands to be purchased as precise measurements will be needed. The bike stands which are most suitable and attractive for the space are two rounded A stands made of Galvanised Steel. There is a stainless steel option but this is more expensive. **Resolved:** quotes will be sought for the bike stands and the paving. The Bike Stand will be purchased from the remaining Carnival Committee Fund.

# d) Eastern Links Meeting - Cllr: Mrs. Gay Hill

Cllr: Mrs. Gay Hill attended the Eastern Links Meeting on Tuesday 4<sup>th</sup> October 2022. The meeting was chaired by Neil Jury, Leader of WDBC. At the 'Superlinks' meeting in December 2021 WDBC were committed to relaunching the area Town and Parish Links Meetings.

Team West Devon aims to nurture local partnerships to consider and respond to issues. Bringing together the Borough Council, Town and Parish Councils and eventually other community leader organisations that support our residents and communities.

The meeting heard from the Economy Team about the UK Shared Prosperity Fund and Levelling up. **Noted.** 

# e) DALC AGM and Conference - Cllr: Mrs. Gay Hill

Cllr: Mrs. Gay Hill attended the DALC AGM and Conference on Wednesday 5<sup>th</sup> October 2022 at Exeter Racecourse. Three key note speakers covered topics including A County Deal for Devon, Devon's Housing Crisis and the new Integrated Care System for Devon. In the afternoon there was a choice of 8 workshops, Cllr: Mrs. Hill attended Planning and affordable housing and Encouraging people to stand for election. **Noted.** 

## f) Climate and Ecological Working Group - Cllr: Gay Hill

A meeting of the Climate and Ecological Working Group was held on Monday 3<sup>rd</sup> October 2022. Four attended. Discussed the Climate and Ecological Event held on 3<sup>rd</sup> September, group now looking at what came out of the event and will report back. Spoke about progress which had been made ie bike stands, tree planting, change to LED street lighting. Suggestion made to find a Wildlife Warden. The numbers of the Climate and Ecological Working Group seem to be dwindling. Ascertain who on the group wishes to continue and then reach out to others. **Noted.**

## a) Jubilee Field Inspection Report - Cllr: Rachel Short

Cllr: Rachel Short reported that the litter was not too bad on the field. There was mole activity on the field. Two of the newly planted Poplar Trees had died. The play equipment was in good order. **Resolved:** Paul Bartlett, Stone Lane Gardens, will order replacement trees.

b) Public Convenience Inspection Report – CIIr: Rachel Short CIIr: Rachel Short reported that the Public Conveniences were in good order. Noted.

## c) Light in the Gents Public Convenience

The florescent light in the Gents Public Convenience is faulty, a new tube had been fitted but this was tripping the fuse box. The Electrician was called to looked at the light and confirmed the fitting of the light was faulty. **Resolved:** to ask the Electrician to install a new LED strip light.

## d) See Saw for Jubilee Field

South West Play have looked at the See Saw in the Jubilee Field and confirmed that it is beyond repair. **Resolved:** to get quotes for a new See Saw.

## e) Grass Cutting Contract

The Grass Cutting and Grounds Maintenance Contract ends in March 2023. The Parish Council needs to tender for a Contractor in November to budget for the Financial Year 2023/24. **Resolved:** the Parish Council will seek tenders for the contract.

## f) Southcombe Gardens

Southcombe Gardens are becoming very overgrown and need pruning. **Resolved:** to ask Lee Miller if he would carry out the work.

## g) Bench for Jubilee Field

The Carnival Committee wish to install a backless bench in the Jubilee Field. **Resolved:** it was agreed that the Carnival Committee install a bench in the Jubilee Field as long as they take ownership of the bench and its maintenance.

h) Electric Charging Point Installation in Chagford Car Park Western Power Distribution have carried out the DNO works associated with the electric charging point installation in the Chagford car park. Noted.
