Minutes of the Regular Meeting of the Chagford Parish Council held at Endecott House on Monday 11th April 2016 commencing at 7.30 p.m.

503. DECLARATION OF INTEREST

There were no declaration of interests.

504. CONFIRMATION OF THE MINUTES

The Minutes of the Regular Meeting held on Monday 14th March 2016 were confirmed and signed as a true record.

MATTERS ARISING

505. Public Access Defibrillator (Min: 437 refers)

The Clerk confirmed that she was still waiting for notification from the British Heart Foundation regarding the alternative funding programme. This scheme should be available online in April 2016 onwards. When this funding programme opens a new application will be submitted. **Noted.**

506. The Bus Shelter in Chagford Square (Min: 454 refers)

The Clerk has made enquiries and there is only one key holder to the Bus Shelter which is opened at approximately 7.30 p.m. this is too late for the 7.15 a.m. bus. **Resolved:** to contact West Devon Borough Council to request that the doors be opened for the 7.15 a.m. bus or give a key to the Parish Council.

509. Forestry Lorries

The Forestry Lorries have started travelling through Chagford. 528. Jubilee Field Inspection Report - Cllr: Parrott

Cllr: Parrott reported that the Multiplay had been repaired well. Generally the litter situation was good however the litter in the Skate Park was terrible with bins overflowing. The surfaces around the tractor and the swings were in need of attention. The main entrance gate does not close properly and the Skate Park gate has a loose slat and the self-closer is broken. The gate to the park is coming away from the hanging post.

The grass is recovering well from the damage caused from the resurfacing of the Tennis Courts. There is a mole problem in the field! **Resolved:** to organise a meeting with CELT regarding the agreed four pieces of work that are due to be done on the field. Also speak with Wez Cutler about the rubbish situation in the Skate Park.

530. Update on the Play Equipment (Min: 406 refers)

South West Play has repaired the Multiplay which is looking very good. The Chairman suggested that we obtain a quote from South West Play for replacing the Cradle Swings, to repair the safety surfaces and give ideas for something to replace the Train. **Resolved:** the Clerk will contact South West Play and request quotes.

The Clerk confirmed that she has emailed/written to all who plant the troughs in Chagford. All are willing to continue apart from Mr. Licence who wishes to give up. However Mr. Mike Downing is willing to take it over. **Resolved:** to write to Mr. Downing and approve payment.
