#### 87. CONFIRMATION OF THE MINUTES

**a)** The Minutes of the Regular Monthly Meeting held on Monday 14<sup>th</sup> November 2022 were confirmed and signed as a true record.

#### 88. MATTERS ARISING

a) Bike Racks (Min: 77(b) refers)

Kirsty Howie is in possession of the new bike racks. A quote has been received from All Seasons to remove turf, concrete a pad, supply and lay 2ft x 2ft concrete slabs and fit the bike stands. Material and Labour £900.00. **Resolved:** to check with All Seasons that this includes supplying and laying stones.

b) Reduced Council Tax Scheme West Devon (Min:83(b) refers) Each year the WDBC has to decide whether to continue with, replace or revise its Council Tax Reduction scheme for working age applicants in its area. Council Tax Reduction is a discount for council tax available to people on a low income.

Cllr: Jill Millar has sent the consultation to a number of Parishioners. This consultation is regarding a Council Tax Reduction for people on low income. The consultation will run until 18<sup>th</sup> December 2022.

- c) Urgent Correspondence from Bruno Peek, Pageantmaster regarding forthcoming Coronation of His Majesty King Charles III. Beacons will not be lit for the Coronation of King Charles III, in June next

- year. Buckingham Palace are conscious that the Coronation will take place less than a year after The Queen's Platinum Jubilee Beacons and are anxious to ensure that the events planned for May 2023 have a markedly different look to those of June 2022. **Noted.**
- **d)** A request for a grant from St. Michael the Archangel Parochial Church Council to help with the upkeep of the churchyard. **Resolved:** to award St. Michael the Archangel Parochial Church a grant of £500.00.
- e) West Devon Borough Council have finalised the costing for the cleaning of the toilets for 2023/24. There is a more significant increase this year compared to previous years due to the inflation rate. The contract price in terms of cleaning has therefore significantly increased to the Council. To provide cleaning at Chagford toilets for 2023/24 is £3629 (includes Wallgates). Resolved: it was agreed that WDBC should continue to clean the Chagford toilets for 2023/24.

The Finance Group met on Thursday 8<sup>th</sup> December 2022. The accounts were reviewed for accuracy checking invoices, statements, cheques and the receipts and payments book. As prices rise discussions were had on projected costs for the coming financial year. At the present time the

Parish Council are well within budget, however there are expenses to come i.e., new see saw, fencing and a new noticeboard. The Finance Group considered that the precept should increase to £60,000.00. To finalise the decision when details of the number of Band D equivalent properties is known. **Noted.** 

- **b)** Approval to the renewal of the Devon Communities Together Membership. **Resolved:** to approve renewal of membership to Devon Communities Together.
- **c)** Request from Citizens Advice TNMWD for a grant. **Resolved:** to approve a grant of £100.00.
- **d)** Approval to reissue Parish Online payment due to cheque not being received and to cancel the appropriate cheque. **Resolved:** to approve payment.
- e) Notification of external auditor appointment for 2022-23 financial year for the 5 year period until 2026-27. Smaller Authorities Audit Appointments (SAAA) is the independent, sector led organisation responsible for the appointment and contract management of external auditors to small authorities. - c) Some of the Dartmoor Commons Owners Association committee are meeting senior DNPA staff in January to look at pedal bike damage on the

- d) The DAA Community Landing Sites will be adjusting some of the internal numbers that they use within DAA and also adjust a couple of the numbers that sit within the GSM Operating system. **Resolved:** the Clerk will inform the Recreational Trust when she is contacted by DAA.
- e) Introductory message from Insp Chris Conway. Insp Conway will be working in the West Devon area and is cognisant that the towns of North Tawton, Hatherleigh, Chagford and Princetown as well as the dozens of surrounding parishes should feel connected to the police. **Noted.**
