- d) Temporary Prohibition of Through Traffic Monday 20 March – Friday 31 March 2023 – Rolling Road Closure, only one road will be closed at any one time. Mill Street, road from Factory Cross to Waye Cross, road from Factory Cross to Way Down Cross and road from Gidleigh Lodge to Factory Cross, Chagford and Murchington. Noted.
- e) Changes to Council Tax Reduction scheme aimed to help more people in West Devon
 - Following a public consultation, West Devon Borough Council is planning to broaden the scope of its Council Tax Reduction scheme in light of the cost of living. The proposed changes are designed to give low-income households the opportunity to earn a little bit more and still received help with paying their council tax. **Noted.**

- f) Chagford Show Community Fund invitations for applications now open. The Directors of the Chagford Show has agreed to donate a % of the profit from 2022 to a charitable fund to help local organizations or projects withing the Show District, which comprises the parishes of Chagford, Drewsteignton, Gidleigh, Manaton, Moretonhampstead, North Bovey, Throwleigh, South Tawton, Spreyton, Lustleigh, Cheriton Bishop and an area within half a mile of the Bridge at Postbridge. Noted.
- g) '20 is plenty' A resident of Chagford is becoming increasingly concerned about the speed of vehicles entering Mill Street at the Manor Road/Mill Street junction and the risk being caused to the residents. Resolved: to continue to lobby Devon County Council Highways for a 20 mph limit.
- h) Nominations for Garden Party at Buckingham Palace DALC has been allocated 4 tickets for a Garden Party at Buckingham Palace on Tuesday 9th May 2023 and are welcoming nominations to attend. Resolved: Cllr: Mrs. Gay Hill has been nominated.
- i) Climate and Ecology Working Group An email has been received from members of the Climate and Ecological Working Group expressing their disappointment by the Parish Council's decision to terminate the Council's official association with the group. Resolved: the Parish Council is still committed to the Climate and Ecological Working Group and when the proposal to dissolve the working group was carried there was a condition which stated that the Parish Council would continue to support the group. It also recorded the fact that the Parish is represented on the Devon Climate and Emergency Group by DALC, DNPA and WDBC.
