Minutes of the Regular Meeting of the Chagford Parish Council held at Endecott House on Monday 14th June 2021 commencing 7.30 p.m.

19. APOLOGIES FOR ABSENCE

Apologies were received from Cllr: Mrs. Phelps.

20. DECLARATIONS OF INTEREST

Cllr: Coombe declared an interest in Minute 29(e), 29(i)

Cllr: Parrott declared an interest in Minute 29(k)

21. CONFIRMATION OF THE MINUTES

a) The Minutes of the Annual Meeting held on Monday 17th May 2021 were confirmed and signed as a true record.

22. MATTERS ARISING

a) Proposed Cattle Grid (Min: 116(a) refers)

An update on the proposed Cattle Grid had been received. It has been impossible to obtain a third quotation as requested by the Parish Council. There has been a significant rise in steel prices over the last few months, which will reflect in the total costs. At present pledges have been made by the Commoners, Devon County Council and local residents.

Resolved: the Parish Council need to have copies of the revised quotations by Robinson Plant Hire and T.A. Sutcliffe Contracting following the steel price increase. The Council also needs evidence that the Grids will comply with Devon Highways Regulations and be reassured that the contractors have all the necessary certificates to enable them to work on the highway.

b) The Gate on the Bridlepath from the Recreational Trust onto Padley Common (Min: 11(a) refers)

The Chairman confirmed that Cllr: Coombe and a volunteer have repaired the hinge on the gate and have improved the latch which is now accessible for all. **Noted.**

c) Dartmoor Local Plan

The Dartmoor Local Plan was submitted to the Planning Inspectorate for examination on 22nd September 2020. In March public hearings were held by the Planning Inspector. The proposed modification for consultation has now been published and DNPA will be holding virtual events during the consultation. The consultation is open until Monday 19th July 2021. For more information go to <u>Local Plan Examination | Dartmoor</u> **Resolved:** the information has been forwarded to Members.

d) Chagford Parish Council Vacancies

Due to the resignation of two Parish Councillors a Notice of Election was posted on 28th May 2021. Two valid nominations for the two vacant seats were received. Therefore, the election is uncontested. **Resolved:** Chagford Parish Council welcome Jill Millar and Rachel Short to the Council.

e) Climate and Ecological Working Group

A discussion was had on how to take the Climate and Ecological Working Group forward. It was felt that the present group was too big and smaller groups focusing on specific subjects would work better. The groups would then come together every 2 to 3 months and report to the Parish Council. **Resolved:** a meeting will be called on 5th July 2021 at Endecott House commencing at 7.30 p.m.

f) Tree Guard outside the Market House (Min:11(d) refers) The tree guard outside the Market House has been repaired and the tree which fell down has re sprouted. Noted.

i) DALC Meeting - CIIr: Mrs. Hill

Cllr: Mrs. Hill attended the DALC Meeting via Zoom on Monday 7th June and discussed a range of issues including lobbying to reduce speed limits to 30 mph in country lanes.

It was agreed that Cllr: Chalmers be the new NALC representative as Cllr: Browse is retiring from NALC this year, following many years' service including being Chairman of NALC.

A new Councillor Development Framework will soon be under development, to bring together all the training and development opportunities available to councillors through the association.

There are a number of vacancies open for co-option to DALC. Noted.

j) Chagford Annual Parish Assembly

The Parish Assembly was held on Monday 24th May 2021 at the Jubilee Hall, Chagford.

- II. A request for the installation of Bike Stands around the town. It was acknowledged that there was a requirement for bike stands, the Parish Council will talk to DCC Highways Department and WDBC and then consult with the public with regard to suitable sites.
- III. 20 mph limit within Chagford. There was a request that 20 mph signs should be placed on Lower Street to slow the traffic coming past the school and up into town as the pavements and road narrows, particularly at lower end of the street.

The Parish Council had previous asked for restriction outside the Primary School, but this was refused. Cllr: McInnes informed the

meeting that DCC now has a different view about 20 mph regulations.

Resolved: the Clerk will make enquiries and inform the Parish Council.
