a) Update on the Diamond Jubilee Clock (Min: 29 (a) refers)

The Clerk reported that Cllr: Sampson had looked at the proposed licence from West Devon Borough Council and is satisfied that the Council can agree to this. He suggested that the elevation plans drawn up for the planning should also be included with the licence. Guy Pedrick from WDBC will now send the licence for signing. **Noted.**

a) Kier Construction plans to commence works on the construction of the new Chagford Primary School on Monday 14th August 2017 and is due for completion towards the end of 2018 which will include the demolition of the existing school.
