MATTERS ARISINGS

307. The Clock on the Market House (Min: 240 refers)

Mr. Alan Deacon has very kindly prepared the drawings of the Market House at a recognised metric scale to show how the clock will look once in place. **Resolved:** the drawings will be sent to Dartmoor National Parks along with the Listed Building Planning application.

308. Public Access Defibrillator (Min: 157 refers)

The Public Access Defibrillator has arrived and training carried out. A cabinet is now needed to house the PAD on the outside of the Jubilee Hall. A cabinet has been sourced from ZOLL Medical UK Ltd – The Aivia 200 Cabinet, non-locking, outdoor, heated and alarmed. **Resolved:** to approve payment of the Aivia 200 Cabinet and place the order.

319. Dartmoor Local Plan Workshop – Clirs: Parrott and Mrs. Stanbury

Cllrs: Parrott and Mrs. Stanbury attended the Dartmoor Local Plan Workshop on 8th November 2016 at Parke. The aim of the workshop was to help councils consider and prepare responses to the Local Plan. It is hoped that DNPA will also get feedback from the local communities. **Resolved:** to circulate the comments members have already made and any amendments or further comments should be sent to the Clerk.

321. Okehampton Hospital

Cllr: Mrs. Hill attended a meeting at Okehampton Hospital regarding the closure of 16 beds. The meeting was for all who use the hospital and attended by a Medical Representative from North Devon. The CCG (Clinical Commissioning Group) wish to remodel the health services to make big saving to make local health care become sustainable. RDE would take over community hospitals and services. Okehampton is being used more as a nursing home which impacts on Doctors and Nurses and their skills. **Noted.**

The main issues were of drainage with water running down paths and forming puddles and washing away the gravel.

Proposals to make better wheelchair access around the churchyard especially the path past Bellacouch to the Church office and ways of making a disabled entrance into the main entrance of the Church.

The Church also wants to improve the lighting with better low level lighting and spotlights.

They are also looking at what remaining space is available within the Churchyard. **Noted.**
