434. 0055/15 Moorholme, 9 Stannary Place, Chagford

440. WW1

The application for a Faculty from the Exeter Diocesan Registry to refurbish the War Memorial in the Churchyard has been granted. The maximum grant of £3,000 has also been received. **Resolved:** The Clerk will inform Mr. Ben Jones that the Faculty has been granted, inform him of the recommendations that the Church Architect has made. Request samples from the letter cutter he uses and suggest work at the War Memorial is not started until after Easter.

ENVIRONMENT

441. CELT Meeting (Min: 414 refs)

Cllr: Coombe and Williams met with Peter Shields and Terry Bleakman from CELT to discuss improvements at the Skate Park. It is proposed to reinstate the Devon Bank and to put in new fencing outside the bank adjoining the Jubilee Park and The Health Centre fence making the area secure.

CELT will price up a replacement bin door and possibly a new extra bin. It is also suggested that the willow shelter is removed and replaced with a seat or picnic table. **Resolved:** A specification will be drawn up and when approval from the Council is received tenders will go out.

442. Road Closure

The road between Waye Cross to Parley Hill Chagford will be close due to drainage works on Wednesday 25th – Thursday 26th February 2015. The alternative, signed via Waye Cross, Factory Cross, Mill Street, Manor Road and vice versa. **Noted.**

443. South West Play

Cllr: Coombe met with South West Play to inspect the See Saw which is moving below ground and the surface if lifting. It was thought that the bolts have sheared off which hold the See Saw to the base. South West Play will visit and investigate and try and rectify the problem. **Resolved:** to await South West Plays verdict.

444. Future of Parish Office

The Clerk has had a presence in the Fire Station but has had very little take up, it has been proposed that the Clerk joins with West Devon Connect, who visit Chagford Library twice a month. **Resolved:** the Clerk will join Connect for a few meetings to determine if this is successful.

445. Thank you letters

446. E-mail regarding the Log Lorries

An e-mail has been received from a concerned parishioner regarding the log lorries that pass through Chagford requesting re-routing of lorries. **Resolved:** the re-routing of the log lorries has been investigated by DNPA and Highways in great lengths in the past, it was concluded that there was no alternative route that was suitable.

447. Council tax increase to protect frontline services

A small increase in council tax of just 7 pence per week for the average Band D home, which is equivalent to £3.89 per year, has been agreed by West Devon Borough Council to help to protect frontline services. **Noted.**

448. Strategic Housing Land Availability Assessment

The SHLAA is a technical exercise to help identify possible land that could have potential for housing, employment and traveller uses. It enables a Local Planning Authority to ensure there is enough land for new homes to meet the needs of communities.
