GENERAL PURPOSE & POLICY MATTERS

51 Standing Orders for Local Councils (Mins 435; 39 refer)

A review of standing orders prepared by Cllr Mrs Hill, was circulated to all Members and discussed at length. Cllr Mrs Hill was thanked by Cllr Mrs Milton on behalf of the Council for the considerable effort involved in producing such a clear document. **Resolved:** To refer recommended adjustments to the Working Group to prepare a final document for Council approval.

52 Insurance Renewal – (Min 24 refers)

53 Dog Litter Bin (Mins 443a; 34 refer)

Cllr Bleakman attended a meeting with MS Dill Lord (WDBC) and a representative of FOCSA (WDBC waste collection) at the War Memorial Playing Field to determine the possibility of collecting waste from the proposed new dog bin. The vehicle to be used for the collection was within permitted weight levels (3 tons laden) and a site for the bin agreed.

Resolved: On a proposition from the Chairman, seconded by Cllr Ms Thorn, that the the site and the installation of the bin be approved and the environment committee obtain costs of the bin required and report to the June Meeting.
