56. URGENT BUSINESS BROUGHT FORWARD AT THE CHAIRMAN'S DISCRETION

57. GROUP/REPRESENTATIVES REPORTS

Planning Control Matters

a) Ref: 0367/20 Yellam Farm, Chagford

Proposed: Alteration to existing stables to create vehicle garage. **Resolved:** to support the application. Policy DMD9 applies.

b) Ref: 0367/20 Huish, 21 Mill Street, Chagford

Proposed: Demolition of two storey rear extension and replacement with Passivhaus extension within existing footprint. **Resolved:** to support the application. Policies DMD1a, DMD3, DMD7, DMD12 and DMD14 applies.

c) Ref: 0379/20 Stableyard, Chagford

Proposed: Change of use from office to private school D1. **Resolved:** to support the application, however concern was raised about the width of the splay and the visibility on leaving the property onto Rectory Lane. DMD1a, DMD3, DMD8 and DMD19 applies.

Application for a Lawful Development Certificate

d) Ref: 0360/20 Tunnafords, Chagford

Proposed: Use of part of stable block to office/domestic ancillary accommodation. **Resolved:** to support the application for use of part of stable block to office ancillary accommodation, however, should not be residential ancillary accommodation.

e) Ref: 0296/20 Yardworthy Farm, Chagford

Conversion of first floor of traditional stone barn into self-catering holiday lets. Subject to conditions. **Noted**

f) Ref: 0266/20 Frenchbeer Farm, Chagford

Erection of cattle building (14m x 28m), hard standing and associated landscaping. Subject to conditions. **Noted.**

Grant of Listed Building Consent

g) Ref: 0297/20 Yardworthy Farm, Chagford

Conversion of first floor of traditional stone barn into self-catering holiday let. Subject to conditions. **Noted.**

58. FINANCIAL MATTERS

a) Chagford Parish Council Insurance Renewal

A Pre-Renewal Invitation Document had been received from Came and Company regarding the renewal of the Insurance Policy. The Chairman and Cllr: Parrott had looked at the document and proposed the Council make the following points — a new laptop and printer had recently been purchased, new gates and fences had been installed, new play equipment was in the process of being supplied. It was also felt that the Open Fields should be mentioned as the fields belong to the Council for three months of the year. **Resolved:** the Clerk will send the pre-renewal document to Came and Company so insurers can be approached.

b) Business Banking Switch

A letter had been received from NatWest stating that Chagford Parish Council are eligible to take part in Business Banking Switch. This is an incentivised switching scheme set up to increase competition in UK business banking which provide opportunity to consider offers to switch business current accounts to a participating bank. **Resolved:** to stay with the Parish Council's present Banking system.

60. CORRESPONDENCE AND EMAILS

a) A letter had been received from the BHS Access Officer for Dartmoor. Several horse riders have voiced concern about the gate on the bridlepath from the Rec Trust Lane onto Padley Common. The gate swings both ways and is latched using a metal bracket which is difficult to manage from horseback. As the gate is on an official bridleway, it should conform to the BHS rider-friendly design. Resolved: the Parish Council will investigate options for latches/gates as the bridlepath has to be fit for purpose for many people ie disabled access as well as walkers, cyclists etc not just horse riders.
