The Chairman reported that expenses had risen this year – Clerks Expenses, Office Expenses, Insurance, Lengthsmans Duties, the Jubilee Field, Grants and the additional costs of Cross Tree Path, Legal Fees for the Swimming Pool Lease and Civic Events.

Although the bank accounts looked healthy at present the Council had many outstanding financial commitments – work on the Jubilee Field, Legal Fees, Insurance and cleaning of the Market House. The Market House will also need some maintenance work done on it in the future. The purchase of a new burial ground is still on going and the Parish will soon take over the open space, toilets and car park at the new development.
