Minutes of the Extraordinary Meeting of the Chagford Parish Council held at Endecott House on Monday 25th June 2018 commencing at 7.30 p.m.

30. APOLOGIES FOR ABSENCE

Apologies had been received from Cllrs: Hamer, Parrott and Mrs. Thorn.

31. DECLARATIONS OF INTEREST

Cllr: Lloyd Hill declared an interest in Minute 34(a) Cllr: Lloyd declared an interest in Minute 35(a)

32. HELEN DOBBY, GROUP MANAGER, COMMERICAL SERVICES AND LOCALITIES

Helen attended the Meeting of the Chagford Parish Council to discuss the services provided to Chagford by West Devon Borough Council.

Helen deals with Commercial and front line services such as rubbish collection, recycling, car parking and street sweeping.

FCC is the Environmental Contractor and their contract is coming to an end in March 2019 so WDBC has a legal obligation to test the market for the best value for money to take over this contract.

The street cleaning is governed by the Environment Protection Act and is cleaned in zones working to guide lines. The size and times the street sweeper comes to Chagford was discussed as it is very difficult to sweep the streets due to the amount of cars parked.

The clearing of gullies and drains is carried out be Devon County Council.

The new system of recycling seems to be working well.

Matt Rawlins is the Localities Officer for Chagford who is responsible for dog fouling, litter etc and can issue spot fines.

The "Refill Scheme" was discussed where traders could be involved rather than having recycling bins. Chagford could promote the Fountain for drinkable water.

It was pointed out that Chagford Car Park was looking rather shabby and Helen confirmed that it was due for refurbishment. **Noted.**

34. GROUP/REPRESENTATIVES REPORTS Planning Control Matters

a) Ref: 0279/18 Forder Farm, Chagford

Proposed: Erection of two agricultural buildings (22.5m x 9m and 18m x 9m respectively). **Resolved:** to support the application to encourage farming to continue as the present buildings are not fit for purpose.

b) Ref: 0179/18 Amended Plans – Church of England Primary School Proposed: Demolition of former School House. The amendment relates to details of demolition and reinstatement of site. Resolved: to support the application however would like further information regarding the reinstatement of the site, the site and highway should be kept clean/clear of dust and mud and to reiterate that CPC regret that a perfectly good house is being squandered.

c) Ref: 0190/18 50 New Street, Chagford

Conversion of existing store above garage to ancillary accommodation and enclosure of balcony. Subject to conditions. **Noted.**

Group Reports

f) Eastern Links, 21st June 2018 - Cllr: Mrs. Hill

Insp Sloman reported violence with and without injury has seen an increase. There has been a big increase across West Devon in vehicle crime, mainly vehicles parking in beauty spots. The reduction in PCSOs will mean less visibility for the Police in rural areas, the Police are looking at other ways of trying to connect with the Community.

Steve Mullineaux from WDBC reported that the NHS budgeting in the south west area, there was an overspend of £130 million last year, they need an additional savings of £0.5 million to keep losses at that figure this coming year.

The re-cycling system had changed recently, vehicles have changed and there was some disruption to services but overall the change has been positive. The new vehicles have in cab technology assisting tracking issues.

Waste services – the existing contract is coming to an end, WDBC are going through a procurement process at present.

The Joint Local Plan – there will be a consultation on the amendment to the Joint Local Plan in December.

Jo Rumble from DNPA informed the meeting that Bill Hitchins had been re-elected as Chairman, Vice-Chairman Maurice Retallick. The West Devon represented by Cllr: James McInnes, Philip Sanders and Bill Cann.

A review of National Parks has started but will take a further 2 years to be complete.

New car parking charges have been introduced at Postbridge, Haytor and Meldon.

The Communities Together Fund – DCC wished to relaunch the TAP Funding scheme focussing on what it was originally designed for – Towns and Parishes working together. The other main change is that the fund is open to other voluntary and community groups.

It was reported that Lesley Smith, Secretary of DALC, will be retiring in October.

Devon Resilience Forum, 14th June 2018 – Cllr: Miss SteadPaul Davies ACC Devon and Cornwall Police reported that the South West was vulnerable to all types of emergencies, terrorism, fires, flooding etc.

Devon and Cornwall Police welcomed voluntary groups and their assistance.

It was applauded the work being done on Emergency Plans.

Toby Russell from Devon Air Ambulance talked about the night landing sites. There are 76 live sites with 200+ in progress. There have been 137 deployments to date and services will be extended to 2.00 am.

Neil Hamlyn – Local Resilience Forum Manger coordinates multi agencies again highlighted the value of voluntary groups.

In the afternoon there were workshops – Emergency Centre Setups and Responsibility for Watercourses. **Noted.**
